FODAML Updates JK 12/3/2024

- Director Transition. Bonnie Lord will be serving as Interim Director once Jane retires on Dec. 20. The search for a new Director will start in January. Plans for the transition are underway.
- Jane shared Strategic Plan 2024-2027 (available at damlvt.org), which staff, Library Trustees, and other stakeholders have been working on since last spring. The plan will guide the Library in decision-making in the coming years, and support our vision that "Together we will create a sustainable library that meets the needs of the growing community and where all are empowered to thrive." Thank-you Friends for supporting us in our vision!
- Schematic Design Process

The Schematic Design Advisory committee meets on Thursday and will be finalizing the site layout and interior plans for the Library renovation and expansion. Once finalized, estimating will done to come up with a cost, which will be presented to Library Trustees and Selectboard to determine next steps, likely in January.

- Capital Campaign Feasibility Study

The internal assessment is complete and CPG, the consulting firm has shared a summary of findings. The study will need a schematic drawing and cost estimate in order to move to the next phase of interviewing in April 2025.

Two of the recommendations from their assessment to complete in 2025 are:

Conduct a simple annual fundraising campaign (not part of the capital campaign)

with a mailing in the winter or apring of 2025, and reposting an appeal appeals at

with a mailing in the winter or spring of 2025, and repeating an appeal annually at

the end of every calendar year. This will help establish relationships.

2. Select and begin to use a donor database for recordkeeping and online

donations.

- Setting up soon would enable donations to the Library to go directly to the

Friends online. Could also be used at book sale and make it easier to donate to

the Friends.

Jane requested that Friends fund Little Green Light, a donor database

(<u>littlegreenlight.com</u>), annually which the Friends would own but the Library would

setup and manage. Online deposits would go to the Friends account.
